

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to codecontest.org and CodeChangers and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to CodeChangers include codecontest.org, Code Contest, codecontest.org and blobbert.io. The CodeChangers website is a coding competition site. By using the CodeChangers website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, CodeChangers may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase CodeChangers's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

CodeChangers may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site.
